4. Details of our assessment

Routine site inspection of Broadstone WWTW carried out by Environment Officer Peter Jones. On the day of the inspection, It was bright sunshine with no rain. There had been no significant rain within the last 48 hours.

Broadstone WWTW serves a population of around 35. The effluent is domestic in nature. The final effluent receives secondary treatment from a package treatment plant and also passes through a reed bed providing tertiary treatment. The effluent is then discharged to a tributary of Anghidi Fawr.

The chambers of the package treatment plant were checked and the system looked to be operating as designed. The site diary was checked and was found to be up to date.

At the time of the visit the reed bed dry and there was no indication the discharge was having an adverse effect. There was no discharge to the Anghidi Fawr from the outlet point. Photographs of the outlet and reed bed are at Annex A
