De sludge is undertaken when required.

Inspection chamber at SN18221 09944 is in need of de sludge. A tanker attended site recently and owing to the proximity of said chamber a hypervac will need to attend.

There is no telemetry on site, this site is too small to require MCerts.

During the visit, a conversation was held with a local resident, who confirmed that there are no odour issues at this site.

Please confirm to NRW when the hypervac has attended site and completed the chamber de sludge.
