4. Details of our assessment

Site inspection to determine compliance with Regulation 36 notice served on operator.

On arrival gates were locked and the officer was unable to gain access to the rear of the site.

Wastes stored at the front of the site were not compliant with the method described in the FPMP, as a result the notice has not been complied with.

The site is required to store waste in the manner described in the FPMP under **condition 3.4.1** of the permit.

No improvements to the storage of the wastes on site were noted during the time of the inspection. With waste storage non compliant with the submitted FPMP. This has been scored as a **category 2 breach** of permit **condition 3.4.1**.
