4. Details of our assessment

On Thursday, 27th March 2025, Llyr Samuel attended the site, accompanied by Rachal Mallinson, both representing Natural Resources Wales. They met with a staff member on site.

The purpose of the inspection was to assess compliance with the conditions of Permit HB3397TK. This was an unannounced inspection.

Permit Breaches

No non-compliances were recorded against the conditions of the Environmental Permit.

Previous inspections

No permit breaches were recorded during our last inspection on 05/04/2024, see CAR_NRW0043952 for full detail.

General observations

The following observations were made:

The Site (Condition 2.2)

The site infrastructure was well maintained, with no visible cracks or faults observed during the inspection. The fencing was in good condition, ensuring site security. Additionally, Overall, the site was well maintained, with no litter present.

Permitted Activities (Condition 2.1 & Schedule 1)

Skips on-site were well-organised, clearly labelled, and appeared free from non-compliant waste types. All waste was contained appropriately. Site drainage at the time of inspection was working effectively. Please ensure drains are maintained and cleared regularly to prevent ponding of surface water on site

General Management (Condition 1.1)

A staff member was able to promptly locate the permit in the site office and demonstrated a clear understanding of the procedures to follow in the event of an incident.

Waste Returns

Waste return data was checked and were found to be up to date with Q1-Q4 2024 having been submitted.
