4. Details of our assessment

This Compliance Assessment Report was completed following a site visit by Michael Launder on 22 January 2025. The aim of the visit was to discuss recent compliance notifications, and to inspect the area around the South Pit, a water discharge monitoring point at the site.

Compliance scoring for the issues discussed below is addressed in NRW CAR_0046084, issued to the operator on 18 February 2025.

South Pit - pH Exceedances

A site walkover with the HSE Manager showed the recent modifications to the South Pit. This enclosure is to prevent sunlight reaching the water and encouraging algal growth in the stagnant water. This has reduced the frequency of pH exceedances at the monitoring point, however there are still breaches of the upper pH limit set in the permit for this discharge, most recently in January 2025.

No process water enters the South Pit or surrounding drainage, and the operator believes that a combination of drainage from a bird roost on a storage building and the stagnation of the water behind a weir is causing the increases in pH. The operator proposes to remove

the retaining wall that forms the weir, to increase the flushing of the South Pit and prevent stagnation. An action in relation to the proposed changes is included in NRW CAR_0046084.

Cold Venting of Methane

While on site, the Dangerous Occurrence report detailing the cold venting of approximately 4.2 tonnes of methane (natural gas) to atmosphere through an unignited flare was discussed, and the proposed remedial actions. The area was not visited. An action in relation to procedural changes relating to the incident is included in NRW CAR_0046084.
