Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A compliance visit was undertaken on 05/03/2025. The permit (**GWSW1768**) allows a groundwater discharge activity. Two Natural Resources Wales (NRW) Environment Officers and the permit operator were present. The weather was dry.

The grid reference of the spreading point was confirmed. The field was well vegetated and complied with point 2.3 of the permit requirements

The dip solution was stored in accordance with condition 3.1.3 and was provided with secondary containment

The dipping area had a concrete floor, and the draining system ensured that liquid returned to the tank. Everything appeared well-maintained, with records kept beyond the required six year retention period.

The permit holder has completed his sheep dip certificate competence which includes environmental requirements.
