### 4. Details of our assessment

A compliance visit for the permit was undertaken on 11/03/2025. The permit (**GWSW1668**) allows a groundwater discharge activity. Two Natural Resources Wales (NRW) Environment Officers and the permit operator were present. The weather was dry.

The permit holder explained that they've not used sheep dip for several years but are retaining their permit in case they should need it in the future. I informed the permit holder that the surrender fee is currently waived, meaning they can surrender their permit for free if they no longer need it. However NRW would not be issuing a new 'dispose to land' permit if they wished to re-apply. Further options sent via email.

**Other advisory comments:**

The current permit allows for the spreading of six cubic meters of spent sheep dip per annum. However, In line with NRW's position statement the annual limit has now been reduced to five cubic meters per annum. The applicant has not dipped for several years and has confirmed that they have never exceed 5cubic meters. Should the applicant wish to resume spreading in the future, a variation may be required.
