4. Details of our assessment

This compliance assessment report is being produced following a routine inspection of Gwrthwynt Waste Transfer Station. The inspection was conducted by Luke Taylor, Waste Regulation Officer with Natural Resources Wales.

The weather at the time of the inspection was dry and overcast.

The officer was accompanied throughout the inspection by Lindley Evans, site operator.

General Observations

The site was operational at the time of the inspection, with frequent movements of local authority vehicles tipping waste from municipal collection rounds. These consisted of food waste, mixed recycling and non-recyclable domestic waste. This was being managed without adverse noise generation, and there was no excessive odour noted.

There was no evidence of any escape of waste whilst this was ongoing, and the area of the carriageway outside the site was clear of any debris from the vehicle movements.

The site operates a fire monitoring system, incorporating heat sensing cameras at various locations to monitor the waste stacks. This allows the site operators to conduct live monitoring of temperatures throughout the day and the system will automatically trigger an alarm should any heat increase be detected.

W1A General Management - Permit Condition 1.1.1 - ACTION ONLY

There was a significant quantity of scrap metal being stored on the impermeable yard area. Mr Evans stated that this was in the process of being sorted and segregated for onward treatment, but that, owing to the closure of Holyhead Port, there have been delays in waste movements from the site to facilities in Ireland. Drivers have been diverted to dealing with the transportation of waste as a result of the closure, but this has now eased.
