4. Details of our assessment

This Compliance Assessment Report is being produced following a routine inspection conducted by Luke Taylor (Waste Regulation Officer) of Natural Resources Wales.

The weather at the time of the inspection was dry and bright with no wind. The officer was accompanied throughout by the site operator, Graham Grigg.

A previous compliance inspection documented that the operator had applied for planning permission to create a holiday lodge park on the site of the quarry, through the local authority, Powys County Council. That planning was approved in January 2025, and work has begun to alter the level of the quarry as per the planning permission.

In order to alter the level of the quarry floor and achieve the level required, material has been imported onto site under a DoWCoP declaration, which has been reviewed as part of the planning process.

As it stands, there is no material being imported to site, other than under DoWCoP. Mr Grigg stated that he intends to surrender the site permit in the near future, and the buildings associated with the permitted works are due to be dismantled as part of the construction project. As part of the planning process, detailed sampling of the site has taken place, before material was deposited into the quarry.
