4. Details of our assessment

I attended site on an un-announced inspection, the weather was dry and cool following a relatively dry period. This CAR form also applies to Impoundment WA/055/0007/007 and is a duplicate of that CAR form.

On arrival the intake appeared to be abstracting and the HoF notch was not flowing, having been blocked by a build up of stone and gravels. This was causing the downstream reach to be depleted quite significantly given the recent extended dry weather.

ACTION: You need to maintain the scheme to ensure the HoF notch flows are unobstructed. Typically this includes an area of at least 1m upstream of the notch to maintain suitable flows.

It's noted the permit variation has not been actioned following the previous inspection. Given the timescales this has been recorded as another breach but will not be actioned, as the renewal for the license is now less than 2 years and the variation can be included in the renewal.

On my way past the farm I stopped and we briefly spoke about the HEP scheme, I advised you at the time the notch was blocked and you agreed to maintain it. Given this was the case I have given two weeks for further checks and/or maintenance before re-inspection will be considered
