4. Details of our assessment

This Compliance Assessment Report is being produced following a permit surrender visit to Welsh Border Motor Spares, following an application by the operator to surrender site permit. The inspection was conducted by Luke Taylor (Waste Regulation Officer) and Holly Dyke (Enforcement Apprentice) from the Mid Wales Waste and Enforcement team, Natural Resources Wales.

The weather at the time of the inspection was dry and bright with no wind.

General Observations

The site premises is positioned within a small cluster of other commercial units, with a hard standing yard in front. The operator has relinquished the lease on the premises, which have reverted to the control of the landowner. The building has been completely emptied, with no evidence of any waste or equipment remaining on the site.

There were several vehicles parked on the hard standing area in front of the premises, however, the owner of the adjacent business confirmed that these belonged to him or were his customers cars, awaiting mechanical work. He also stated that the premises formally occupied by Welsh Border Motor spares is due to be demolished and replaced with a new unit by the landowners, in the near future.

No evidence of any pollution was identified at the time of the inspection.
