4. Details of our assessment

I attended site on an un-announced inspection, the weather was dry and cool following a relatively dry period.

This CAR form relates to Impoundment WA/055/0007/002.

On arrival the abstraction point appeared unchanged since the last inspection. The sluice appeared to be fully closed but abstraction was still taking place through a hole in the sluice. This is the same as the previous inspection, in spite of the action listed previously. Given the short depleted reach and non-consumptive use, again a C3 breach is being listed. If no action is taken this will be escalated in line with NRW's regulatory principles.

Condition 9.2 (ii), *no abstraction shall take place until the License Holder has installed a gauge board in the river Ellywe*. There is no confirmation of this in our systems. Please confirm if there is a board as required and the agreement from NRW as to its location.

Again the outfall was inaccessible due to the mill being closed and therefore has not been assessed.
