4. Details of our assessment

I attended site on an unannounced inspection, the weather was dry and bright following a dry period; river levels were low. Please note this CAR form also relates to Impoundment WA/056/0054/002.

On arrival at the scheme it appeared to have been maintained relatively recently as the HoF notch was clear but with growth around it. The scheme was not abstracting at the time of visit. The fish easement constructed/modified since last inspection appears to have bedded in well.

On the outfall, the screen in place had been torn slightly and will need repairing. Given the flow and siting of the outfall, this should be done before winter.
