### 4. Details of our assessment

I attended site on an unannounced inspection, the weather was dry and bright following a dry period; river levels were low. This CAR form also relates to Impoundment WA/056/0053/020.

I arrived at the outfall approx. 10:50, the scheme was not discharging and did not appear to have discharged recently. There was no screen on the outfall, although with the style of scheme and current water levels this is unlikely to be problematic. This should be replaced before winter.

At the offtake there was a slight build up of stones and debris around the HoF notch though this appeared to be natural. It's recommended that regular maintenance occurs to keep the area at least 1m upstream of the notch clear and unobstructed. The scheme was not abstracting so all flows were passing over/through the scheme.
