4. Details of our assessment

A routine water resources inspection was carried out by Heidi Markham and Bethan Lewis from the Ceredigion Environment Team on 06 March 2025, who met with Dwr Cymru Welsh Water's South West Water Resources Technician.

Source of Supply and Points of Abstraction

Water is abstracted from underground strata at Point A and Point B by way of boreholes as outlined within Condition 2 of the licence. The abstraction points and meters are located in

underground chambers.

The chamber cover for Point A was opened and a visual inspection was undertaken (Figure 1). Water was being abstracted at the time of the visit.

We were unable to open the chamber cover for Point B during the visit.

No issues were identified.

Means of Abstraction

Point A is a borehole not exceeding 30 metres in depth and 750 millimetres in diameter with two submersible pumps.

Point B is a borehole not exceeding 16 metres in depth and 914 millimetres in diameter with a submersible pump.

No issues were identified.

Purpose of Abstraction

Water abstracted from the underground chambers located at Lovesgrove Point A and Point B is used for public water supply.

No issues were identified.

No non-compliances with licence conditions were observed at the time of the visit, however it is recommended that access to the chambers is maintained to allow for access at all times.
