### 4. Details of our assessment

On the 26/02/2025 a Natural Resources Wales (NRW) officer carried out a routine announced inspection of the Church Stoke Wastewater Treatment Works, A490, Churchstoke, SY15 6DS, on the Camlad river SO 27287 94685.

A representative from Hafren Dyfrdwy was present during the inspection. The visit was undertaken to assess compliance of the site in relation to licence S/01/56174/R.

The weather was generally dry.

The sample chamber appeared to be clean and the effluent was clear and colourless with no suspended or floating materials or oils. The V notch bypass has now been fixed permanently to prevent accidental leakage underneath.

The discharge point appeared clean and correct, there were no signs of sewage fungus, rags etc.

There site is currently having significant works carried out to implement phosphate removal.

No issues were found with the site or licence.
