4. Details of our assessment

A routine water resources inspection was carried out by Heidi Markham and Ffion Quan from the Ceredigion Environment Team on 07 March 2025, who met with Dwr Cymru Welsh Water's South West Water Resources Technician.

Source of Supply and Points of Abstraction

Water is abstracted from the inland waters Llyn Teifi at National Grid Reference SN 7810

6755 (Figure 1) and Pond y Gwaith (Figure 3) at National Grid Reference SN 7785 6760. Both were inspected at the time of the visit, along with the discharge from Pond y Gwaith into Llyn Teifi (Figure 2).

Means of Abstraction

Water is abstracted from Llyn Teifi by siphoning to Strata Florida Water Treatment Works. Water abstracted from Pond y Gwaith is by means of intake works and gravity flow to Llyn Teifi.

No issues were identified.

Purpose of Abstraction

Water abstracted from Llyn Teifi is used for public water supply. The water from Pond y Gwaith is transferred to Llyn Teifi for subsequent re-abstraction or to the Cwm Teifi stream in order to maintain the prescribed flow specified in condition 10 in the licence.

No issues were identified.

Means of Measurement

The quantities of water abstracted is measured by a meter.

No issues were identified.

No non-compliances with licence conditions were observed at the time of the visit.
