4. Details of our assessment

This was a pre-planned site inspection of Rhydlew Pumping Station (PS) No 1 (permit number: BP0013503) carried out by Natural Resources Wales (NRW) Officers Bethan Lewis and Ffion Quan. The NRW Officers were accompanied during the inspection by a Dŵr Cymru Welsh Water (DCWW) Operational Supervisor.

Summary

The site inspection commenced at 09:51 hours on the 26 March 2025 and concluded at 10:29 hours. The weather at the time of the inspection was dry and sunny. The previous day's weather was cloudy and mostly dry.

The NRW Officers were led through the storm and emergency discharge process at Rhydlewis PS No 1 by the DCWW Operational Supervisor.

Storm and Emergency Discharge Process

Sewage reaches Rhydlewis PS No 1 from part of the village of Rhydlewis and from the inlet of Rhydlewis WwTW. The pumping station is shown in photograph 1 below.



Photograph 1: Rhydlewis PS No 1. Wet well exists below grate.

Sewage present in the pumping station's wet well, situated below the grate in photograph 1, is pumped up to the inlet at Rhydlewis WwTW. If the level of sewage within the wet well exceeds a certain level, a spill occurs from the wet well into the Nant Collen at SN 34608 47317. An Event Duration Monitor (EDM) situated within the wet well records the number and duration of these spills. In 2024, the EDM monitor recorded 73 block counted spills into the Nant Collen lasting a total of 667 hours. The EDM monitor was operational 99% of the time.

According to the DCWW Operational Supervisor, all spills from the pumping station wet well are screened through a mesh basket. This screen was not able to be viewed by the NRW Officers at the time of the inspection. Condition 2.3.2(b) of permit BP0013503 states that the discharge must pass through a screen with an aperture size of 10mm. To ensure that this is the case, NRW ask DCWW to supply a photograph showing the aperture size of the screen

at Rhydlewis PS No 1 by no later than the **27 June 2025**.

Photograph 2 below shows the storm and emergency discharge point into the Nant Collen at SN 34608 47317. No discharge was being made into the Nant Collen at the time of the inspection, and no sewage fungus or sewage debris was visible around the discharge point.
