4. Details of our assessment

This was a pre-planned site visit carried out by Natural Resources Wales (NRW) officer Ffion Quan who was accompanied by two Dŵr Cymru Welsh Water (DCWW) operatives.

General Observations

NRW officer Ffion Quan arrived on site at 14:20.

The system at Betws Bledrws is a RBC tank system. The operator visits the site once every two weeks.

The process

The incoming flow into the works is gravity fed directly into the RBC tank. The flow in the RBC tank goes through the treatment from the inlet on the right hand side to the outlet on the left hand side. The RBC tank during the visit was getting to the point of needing emptying and therefore the operational supervisor has organised for the RBC tank to get emptied in the next week.

The final effluent sampling point was observed and the final effluent discharge was running clear at the time of the visit. The outfall was inspected and although there was very little flow, the discharge was clear.
