4. Details of our assessment

NRW officer Ffion Jones attended Grafog Farm unannounced to inspect permit BB3491CQ for the disposal of sheep dip to land. Many thanks Mr Watkins for your time.

Mr Watkins hires a mobile contractor to dip approximately 1000 sheep each year. The dip then is temporarily stored at Grafog Farm and spread to land via this permit as soon as the weather and land conditions are suitable. The spreading location (SO1869826566) has grass cover, is at least 10m from watercourse and 50m from groundwater source and there does not seem to be abstractions for drinking water supply nearby. Spreading occurs once or twice per year, usually in the autumn. Records are maintained of disposal activities.

Spent dip is diluted with water.

12/07/2024 - bought 10L of Golden Fleece

25/10/2024 - used 5L concentrate (600L of spent dip stored following dipping)

05/11/2024 - used 5L concentrate (800L of spent dip stored following dipping)

14/11/2024 - 1400L of spent dip diluted with water and spread at SO1869826566

Advice and Guidance

- 1) Please ensure all unused and used dip is stored appropriately and has secondary containment for any potential leaks.
- 2) Please ensure that following dipping activity that there is no run-off from handling area.
- 3) Please ensure that sheep are kept away from any watercourses for as long as possible.
- 4) Please ensure that spend dip is diluted appropriately - 1part dip to 3 part water/slurry .
