4. Details of our assessment

Inspecting officer Ross Grisbrook accompanied by Jamie Goff, DCWW.

The catchment draining to this asset suffers from high infiltration.

The internal diameter of the rising main is 2 inches and requires weekly treatment with compressed air forced through the pipework to clear growth that significantly reduces the available capacity in the pipe, so impairs pumping efficacy if not cleared regularly. At the end of 2024 the line was 'ice-pigged' to improve the pipework.

During the visit the pumps were operated. The flow settled at 0.98 litres per second. The

pump arrangement in the wet well is two pumps, duty and assist, working either alone or in conjunction. The first pump switches on when the level reaches 1.15 metres, the second when it reaches 1.2. Both stop after the level drops to 1.0 metre.

The permit allows discharges to the adjacent watercourse in times of emergency and storm conditions (when storm overflow setting of 1.25 litres per second is exceeded). Jamie confirmed that there is a 6mm screen in a chamber just before the outfall, but i was unable to view the storm overflow arrangement in the wet well.

According to the 2024 Flows Passed Forward (FPF) spreadsheet, this site does not appear to be failing the FPF parameter.

The regular clearing regime of the rising main is essential to the pumping efficacy of the station and for optimal flows to be passed forwards without the storm overflow setting being prematurely breached. If FPF starts becoming an issue at the site, NRW may discuss ways to reduce the risk of future permit breaches at Pont Yr Hafod.
