Please confirm the latest version of the permit for the asset at Lamack Vale, Tenby BP0267401. The version we hold on file was issued in June 1998 to Pembrokeshire County Council.

If you could confirm when DCWW adopted the asset and that it operates as an Emergency Overflow only and not a Combined Storm Overflow (CSO). The Permit version we hold, suggests it operates as an Emergency Overflow.

DCWW can confirm that the latest version of the permit is BP0267401, dated 1998. This asset is part of the EO to storm programme for AMP 8 under GN021 guidance, it was added to the programme in December 2024. An asset survey has already been completed, and an CCTV infiltration study is programmed in for September 2025.
