*Apologies for the delay in updating you on the action plan to address FPF at Wolfscastle WwTW, detailed in CAR\_NRW0039139. Initially, there was a scheme planned for delivery within AMP7. However, due to a change in scope to align with the revised permit conditions starting in 2030, the delivery has been postponed to AMP8. The scheme will now account for growth, sanitary reduction, and the FPF increase. Delivery is scheduled to commence imminently within AMP8.*
