4. Details of our assessment

This CAR is related to WIRS 2504492 in which NRW received a report that the outfall for Bonvilston West STW was causing a visual impact to the stream. EO Harry Warburton attended the area of the outfall to the stream for Bonvilston West on 09/05/2025. There was low flow in the stream and minor flow from the outfall. The concrete and roughly 4m of the stream bed downstream has sewage fungus, which was not present upstream. The FE from the works seemed to be the majority of the flow in the stream.

A POLFAX was also sent to DCWW on the 9th of May. I received a call from the BGA pollution technician stating an operator was going to site. I mentioned to take an FE sample for BOD and suspended solids. I received the results from this sample from the AGA pollution tech, they mentioned the BOD was 19mg/l with a limit of 18mg/l and the suspended solids was 14mg/l with a limit of 21mg/l, so the BOD was slightly exceeding the limit.

Coincidentally an OSM sample was taken at Bonvilston STW on 08/05/2025. In which there was a BOD exceedance, however this is being addressed separately in CAR_NRW0048482.

The site seems to suffer from low flows through the works during dry periods, so a solution is required to bring this site back in to compliance.

Actions:

- Investigate the reason for the exceedances and impacts to the stream and come up with a way to prevent this from recurring at this site.
