### 4. Details of our assessment

On 16<sup>th</sup> May 2025 Officers from Natural Resources Wales attended Beech Rd CSO to carry out a compliance visit against permit number BW3200301. Officers were met with 3 employees from Dwr Cymru. The weather on the day was warm and dry, there had been no significant rainfall for the previous 2-3 weeks.

During the visit no concerns were raised and no breaches of compliance were noticed. The asset appeared to be working as designed.

No discharge to the environment was occurring at the time of our visit and there was no sewage detritus present at the outfall. The outfall was partially blocked with sand although effluent could escape through the upper part of the storm flap.
