### 4. Details of our assessment

Dear Dwr Cymru Cyf.

Storm Tank EDM Spill Data was provided as part of the Data Request No. 2229, however, no monitoring available for Passed Forward Flow (PFF) and EDMS.

Drop test was undertaken by Dwr Cymru Cyf. on 29th November 2024. This drop test has highlighted some issues with the Menai Bridge No. 3 SPS PFF. Dwr Cymru Cyf. have

informed NRW of the results and that a wider investigation is required linked with the rising main design and the operation of Menai Bridge SPS No. 2. Dwr Cymru Cyf.'s Ops are looking into this issue. Please supply an update.
