4. Details of our assessment

CARS form generated following data audit for Beddgelert STW (CG0024001) for the period 04/10/23 00:00 - 04/10/24 23:59.

In a previous CARS form (CAR_NRW0045806) following analysis of the data we questioned what site improvements had been done at Beddgelert STW to enable the site to go from 2,594 hours of spill in 2022 and 1,172.50 hours of spill in 2023 to 0 seconds of spill for the data period we looked at.

Following this Dwr Cymru identified that there was a EDM set up error which meant the correct signals were not being received to log a spill.

This is a breach of permit under condition 1.1.1 (a) (b) which requires EDM to be monitored. This also means the 0 hours of spill for the period which the data was analysed is incorrect and the actual figure for this period is unknown.

Without this data any impact the site may be having on the environment is unknown.

Please ensure the EDM monitor is working as designed and that all monitoring at the site is being recorded accurately by 11/03/25.

Amendment

CARS form amended 09/04/25 following a challenge from Dwr Cymru.

Categorization has been downgraded from a C2 to a C3 as Dwr Cymru were able to demonstrate monitoring using storm tank height data. This data could be used to identify if there were any environmental impacts during the period 04/10/23 00:00 - 04/10/24 23:59 instead of the EDM data which was not recorded due to a failure with the EDM monitor. The EDM has since been fixed at this site.
