4. Details of our assessment

Landfill Emissions Reduction Project Gas Audit

A landfill gas audit was undertaken on the 1st of July 2024 by Mostyn Wall, Tony Roberts and Susan Francis of Natural Resources Wales. The NRW officers were accompanied by staff from Gwynedd Council.

The aim of the audit was to assess if the site operator can collect and treat landfill gas generated at the site. Assess if the site is being operated and maintained to maximise gas collection efficiency and minimise fugitive landfill gas emissions. The audit is part of the Landfill Emission Reduction Project (LERP) that aims to audit all major landfill gas sites in Wales.

During the site visit an audit of the gas infrastructure, capping and gas field was undertaken by NRW officers.

An in-depth audit report is contained in a separate document and should be read in conjunction with this CAR.

The gas audit found the site to be well run and compliant with the sites permit. The site is collecting and treating landfill gas effectively at the site. Only minor defects & recommendations were identified during the audit.

Actions

- Complete all recommendations outlined in the LERP audit. For each recommendation the operator needs to state how they intend to resolve each issue and provide to NRW a completion date.
