4. Details of our assessment

Dear Richard Simpson,

On the 25th of February 2025, Environment Officers Callum BRANNAN and George NUTTALL carried out a site audit of the discharge permit CM0141901 at Chirk Fishery. There were no issues on the day and the operation was compliant with the permit.

As well as the audit, the changes to the permit regarding the addition of a phosphate limit were discussed. The permit will be varied by NRW in 2025 and will be effective by 2030. A letter will have previously been sent to Chirk Fishery by NRW regarding these changes.

No samples were taken at the time of the audit. Compliance samples are routinely taken by our monitoring team. Any non-compliances arising from these samples are dealt with separately.
