This report is in reference to the Abstraction Licence WA/065/0014/002

The 'Owen Geraint Ellis' Hydropower site at Gelli Ffrydau, Nanlle, Caernarfon was visited on the 28/7/2022 at 13.30 by Environment Officers Swyn Spencer and Stuart Jones from Natural Resources Wales.

During the inspection the following non-compliance with the licence conditions had been

noted:

Discharge outfall pipe screening (at point Q area)

Condition 9.7 (also 9.1 repeats it); No abstraction will take place unless the licence holder has installed a screen with spacing no greater than 10 millimetres to the discharge outlet pipe to prevent the entrapment, entrainment, and impingement to fish. This was not compliant with the licence, as there was no discharge outfall screen present. Please install a **screen** as per licence.

A screen is now installed and approved by Fisheries Officer. Please ensure it's maintenance.
