LANDFILL GAS MIGRATION ASSESSMENT/NEW BOREHOLE INSTALLATION - FOLLOW UP

23rd April 2025

Following the issue of CAR form Number: 45433, recommending the installation of a new gas monitoring borehole to assess gas migration at the most vulnerable area of the site, where the waste mass in the old Area 2 is closest to the operational buildings, a site inspection was undertaken to check satisfactory installation and operation of this key addition to the gas infrastructure.

The permit requires the following:

2.8 Landfill Gas Management 2.8.1 The operator shall take appropriate measures, including, but not limited to, those specified in any approved landfill gas management plan, to: (a) collect landfill gas; and (b) control the migration of landfill gas.

The new gas borehole was fitted as requested and has been sampled showing no signs of exceedance of methane limits for perimeter boreholes.

No further action is needed at this time.
