This Compliance Assessment Report (CAR form) is being issued following receipt of the compliance sample analysis results for Biochemical Oxygen Demand (BOD) taken of the sewage discharge on the 1st of April 2025.

The sample results for BOD was 21mg/l compared to the permit limit of 20mg/l.
