4. Details of our assessment

The non-compliance listed above was identified during our annual 2024 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/24 as these non-compliances relate to annual 2024 data, however for clarity I carried out the compliance assessment on 12/05/25.

The ASR, Changes to Sample Frequency tab, sets out that the frequency required was decreased after May 2024. This was not the case and sampling was planned and completed for twice a month for the whole of 2024.
