## 4. Details of our assessment

**Updated and resent on the 04/06/2025 to include a C2 for suspended solids permit breach.**

Gorse Hill Caravans Ltd treatment plant (CG0123301).

The samples taken were analysed at the NRW laboratory based at Swansea University.

The results are as follows -

Biochemical oxygen demand – BOD 34mg/l. Permit limit 20mg/l.

Suspended Solids – 71mg/l. Permit limit 30mg/l.

**As part of this CAR form a WARNING has been issued.**

**Further advice given.**

Environment Officers for NRW have discussed via telephone the results with Rob Thomas and the groundsman and have suggested the plant is given extra bacteria to aid in treatment.

NRW officers also discussed the use of chemicals within the park such as bleach which could be having an adverse effect on the functionality of the treatment plant, NRW's advice in this regard would be to regulate the use of products such as bleach within the caravan park.

### **Actions**

NRW are requesting the plant is fit for purpose to meet its permit requirements NRW are requesting that Gorse Hill prepare and action plan which is put into place no later than the 30th June 2025.

As part of the compliance monitoring program further samples of this site will be taken in Q3.
