#### **4. Details of our assessment**

This compliance form is the result of recent failures identified from monitoring samples taken by NRW on the 31st of March 2025.

The results from these samples were the following:

Suspended solids: **73mg/l** (permitted limit: **60mg/l**)

Ammonia: **49.3mg/l** (permitted limit: **20mg/l**)

BOD: **74.9mg/l** (permitted limit: **40mg/l**)

The above results table indicates that a sample taken of the discharge from the Marconi Holiday Villages treatment works on the 31st of March 2025 for which you hold the permit, exceeded the permitted limits for Suspended Solids, Ammonia & Biological Oxygen Demand.

These results, together with all other results taken for the purpose of permit monitoring, will form part of the public register held by the Natural Resources Wales and are available for inspection by any member of the public.

Please inform NRW within fourteen days the reason for this failure and the steps that you intend to take or have taken to prevent recurrence. I shall have regard to your response when determining what further action Natural Resources Wales may take to ensure compliance with the permit.
