4. Details of our assessment

The non compliance listed below was identified during our annual 2024 data audit. This audit assessed Dwr Cymru/Welsh Water's compliance at all their sewage treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions

Please note that the CAR is dated 31 Dec 24 as this non compliance relates to annual 2024 data. However, I clarify I carried out the compliance assessment on 12 May 2025.

Breach of permit reporting condition 4.2.2 was noted on the 31 December 2024. Condition 4.2.2 states:

Within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- in respect of the parameters and monitoring points specified in schedule 4 table S4.1;
- for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and
- giving the information from such results and assessments as may be required by the forms specified in those tables.

The breach was recorded for not providing the data in the required format. The ASR, changes to Sample Frequency tab, sets out that the frequency was increased from monthly to twice a month.

This is not the case, the frequency was increased from quarterly in 2023 to twice a month scheduled from Feb but taken from March 2024 (due to fluvial flooding). The end date of increased frequency is also incorrect as should be end of Feb 2025 not end of April 2025. Therefore, the Annual Summary Report is not accurate.
