## 4. Details of our assessment

water quality sample take on 22/1/2024 resulted with a permit breach on condition 7 suspended solids limit of 50mg/L the result of the sample was 73.5. I believe this was partly due to storm condition leading up to the sample being taken.

Additional mitigation should be put in to deal with weather conditions if the current settlement pools are insufficient.
