4. Details of our assessment

The non-compliance listed above was identified during our annual 2024 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions.).

*** Non-Compliance ***

4.2.2- A DCWW Waiver request was not appropriately recorded on the Annual Summary Report Numeric Failures and Exceedances tab. This is therefore a breach of permit condition 4.2.2 which states the following.

4".2.2- Within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- a. in respect of the parameters and monitoring points specified in schedule 4 table S4.1;*
- b. for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and*
- c. giving the information from such results and assessments as may be required by the forms specified in those tables."*

This has been classified as a category 4 noncompliance, which has no potential impact on the receiving environment. As this relates to an error in recording a waiver request. No environmental impact is suspected as a result of this noncompliance.

Please note: this CAR is dated 31/12/24 as these non-compliances relate to annual 2024 data, however for clarity I carried out the compliance assessment on 12th May 2025 .
