An Odour Management Plan has been submitted which discharges the requirement of this condition.

IC8 The Operator shall submit to Natural Resources Wales an updated written procedure(s) describing how they intend to meet the following BAT requirements in accordance with requirements specified within: • BAT Conclusion 13 of the Food, Drink and Milk Industries BRef Document (EU 2019) – Set up, implement and regularly review a Noise Management Plan (as part of the EMS) that includes all of the specified elements

A Noise Management Plan has been submitted which discharges the requirement of this condition.

IC9 The Operator shall submit to Natural Resources Wales an updated written procedure(s) describing how they intend to meet the following BAT requirements in accordance with requirements specified within: • BAT Conclusion 2 of the Food, Drink and Milk Industries BRef Document (EU 2019) – Establish and maintain a waste water and waste gas inventory as part of the Environment Management System

A summary document to show the waste water and gas inventory maintained as part of the EMS has been submitted which discharges the requirement of this condition.

IC10 (a) The Operator shall submit to NRW the maximum capacity of the installation that was used in the most recent risk assessment submitted to NRW. (b) The Operator shall submit to NRW for approval the maximum capacity of the installation at the current time. (c) If the maximum capacity of the installation has increased from the time of the last submitted risk assessment and the current time, the Operator shall review and update the risk assessment to account for the current maximum capacity. The risk assessment shall be submitted to NRW for review.

The Operator has provided the following response which discharges the requirement of this condition.

Please find our response below to satisfy improvement program requirements for IC 10 maximum capacity of the installation for your approval.

- a. The maximum capacity of the installation that was used for the most recent risk assessment was 720 tonnes per day
- b. The maximum capacity of the installation at the current time is 720 tonnes per day.

- c. As there has been no increase in the maximum capacity, no update to the risk assessment is required to account for any increase in capacity.
