4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced to acknowledge receipt of and authorise Knauf Insulation Limited's notification of Electrostatic Precipitator (EP) shut down and operation of the site's by-pass stack.

The shut down and by-pass stack operation is authorised to take place between 21/04/25 (10:00) – 24/04/25 (10:00) for the purpose of undertaking routine EP maintenance, subject to the following measures.

Measures taken, or intended to be taken, to rectify, limit or prevent any pollution of the environment which may be caused by the emission are: glass pull rate and production output to be reduced by 75% and visual monitoring of bypass stack.

As per condition 4.3.5, where the operator proposes to make a change in the nature or functioning, or an extension of the activities, which may have consequences for the environment and the change is not otherwise the subject of an application for approval under the Regulations or this permit: Natural Resources Wales shall be notified at least 14 days before making the change.

With the referenced revised notification being made 1 April 2025, this notification falls within the 14 day notification period.

The notification and proposed activity represents compliance with permit conditions 4.3.5, 3.1.1 and 3.1.2.
