This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q1 (January - March) 2025 monitoring returns by Dunbia (UK) for activities at Cross Hands Meat Processing Plant, Cross Hands Business Park West, Llanelli SA14 6RF under permit EPR-BU8002IT.

Q1 2025 Monitoring Returns

Emissions to water - Water 1 / 14/04/2025

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to discharge point W5 for Q4 (1 January - 31 March) 2025 were submitted to NRW on 14 April 2025.

Emissions to sewer - Sewer 1 / 14/04/2025

The returns for reporting of sampling and analysis of emissions to sewer to discharge point S1 for Q1 2025 were submitted to NRW on 14 April 2025.

SCHEDULE 5 NOTIFICATION SUBMISSIONS

On 6 and 20 February 2025, the operator respectively submitted a schedule 5 notification containing a Part A and B detailing an exceedance of ammonia at W5 in January 2025.

Table S3.2 point source emissions to water dictates that:

Ammonia shall not exceed:
• **0.25 mg/l**

On 23 January 2025 ammonia was recorded at a value of 1.70mg/l - this reading has exceeded the ELV specified in S3.2. The operator has provided the following explanation on its investigation and action:

ELV exceedance source likely linked to the disconnection of a drain hose for the Portapacker resulting in a small quantity of blood contaminated liquid around the base of the unit. A small quantity of residual material may have gone onto the yard during collection making its way to W5 via drainage network.

Corrective action was taken by the operator to service the kit and washdown the area to the effluent drainage channel. Procedures for clean down updated to capture this potential event going forward.

In accordance with NRW's compliance scoring guidance, a non-compliance score of **C3** has been recorded against sub-criteria IR3A.

Compliance summary

- The monitoring data was sent within the Q1 reporting period, which is **compliant** with permit condition 4.2.3.
- The monitoring was conducted inside the Q1 monitoring period, which is **compliant** with permit condition 3.5.1.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified limits over the Q1 2025 reporting period.
