This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q1 (January - March) 2025 monitoring returns by Materials Recovery and Energy Centre for activities by Neath Port Talbot Country Borough Council at Crymlyn Burrows, Swansea, SA1 8PZ under permit EPR-BJ5775IF.

Q1 2025 Monitoring Returns

The returns for reporting of sampling and analysis of emissions for Q1 2025 were submitted to NRW on 3 February, 3 March, and 1 April for the months of January, February, and March 2025 respectively. The following documents have been submitted and reviewed:

The monitoring data was conducted within the Q1 2025 monitoring period, which is **compliant** with permit condition 3.5.1.

The monitoring data was sent within the Q1 2025 reporting period, which is **compliant** with permit condition 4.2.2.

The monitoring data was reported in accordance with Table S4.1 and S4.4, which is **compliant** with permit condition 4.2.4.

Emission point A2 remains disconnected to any plant equipment on site. As the Waste to Energy Plant was decommissioned in 2013 all emissions to air have been submitted with NIL result.

Based on the reports submitted by the operator, all other emissions at the monitoring points appear compliant with the specified emission limits over the Q1 2025 reporting period.
