4. Details of our assessment

During a routine compliance assessment check that we have carried out on 08/04/25 it was noted that the EDM operational time for this asset was less than the minimum of 90%.

The operational time provided in the 2024 EDM Annual return AN0093801 Asset No. 32207 Celtic Steel Factory CSO was 89.04%

Condition Monitoring 3.1.1 states that “*The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit: (a) point source emissions specified in tables S3.1 and S3.4.*”

Guidance for scoring the non-operational time suggests that this may have had a Category 4 Impact-when the EDM is operational for 60.01-89.99% of the calendar year. It’s reasonably foreseeable that that there will be no environmental impact as the percentage indicates that the overflow is receiving reasonable monitoring and that the operator is likely to have reacted to any operational issues in a timely manner.
