#### **4. Details of our assessment**

During a routine compliance assessment check that we have carried out on 02/04/2025 it was noted that the EDM operational time for this asset was less than the minimum of 90%.

The operational time provided in the 2024 EDM Annual return for AN0124201 , Junction of Sunnyhill & Park Crescent CSO, Cwmparc was 1.9%.

Condition 3.1.1. states that the operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit: (a) point source emissions specified in tables S3.1 and S3.4.

Guidance for scoring the non-operational time suggests that this may have had a Category 2 impact.

Category 2: when the EDM is operational for 0-10% of the calendar year. The lack of data makes it unlikely that the operator can confidently assess the performance of the asset. It also suggests that the overflow is receiving inadequate, or no monitoring and that the operator has not resolved operational issues in a timely manner.

Actions – please carry out the actions specified above to comply with permit condition.
