4. Details of our assessment

During a routine compliance assessment check that we have carried out on 01/04/2025 it was noted that the EDM operational time for this asset was less than the minimum of 90%.

The operational time provided in the 2024 EDM Annual return for AN0047801 Penarth Llandough Moors Cardiff CSO was 77.76%.

Condition 3.1.1 states that *"The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit: (a) point source emissions specified in tables S3.1 and S3.4."*

Guidance for scoring the non-operational time suggests that this may have had a Category 4 breach: When the EDM is operational for 60.01-89.99% of the calendar year. It suggests that the overflow is receiving reasonable monitoring and therefore the operator is likely to have reacted to operational issues in a timely manner and they can be reasonably confident whether the SFT limit has been exceeded.
