4. Details of our assessment

Reporting

The Q1 2025 results for the parameters listed in Table S2 of the permit were sent to NRW as per condition 4.1.2(a).

Reporting of parameters in Table S2 was submitted on the forms specified in Table S3 as per 4.1.2(b).

Emissions

Q1 2025 emissions reported for W1 & W2 and S1 are compliant with the permit condition 6.3.2 and 6.4.2 emission limits.

Schedule 1 Notification

NRW received a schedule 1 part A and B notification on 24th April 2025.

86kg of R449A was lost from a rented freezer unit due to a leak on a defrost valve. The emission took place on 15th April 2025.

The leak originated from the O-ring to the reverse cycle defrost valve. The O-ring was replaced, the valve was sealed, and the system was pressure tested to ensure the repairs held. The unit maintenance is contractually the responsibility of the owner. Kepak will be exploring whether a leak detection system can be adopted on all rented units.

R449A is an F-gas with a CO₂eq of 1397. An 86kg leak is therefore equivalent to 120,142kg of CO₂.

The release of 86kg of R449A is considered **a category 3 non compliance with condition 6.1.1.**

Action: Please ensure that rented equipment is fully considered in your refrigerant management plan.

You may be aware that the Best Available Techniques (BAT) document for Slaughterhouses, Animal By-products and/or Edible Co-products Industries has been published for the EU as of December 2023. Within the document, BAT 20 states the following:

BAT 20. In order to prevent emissions of ozone-depleting substances and of substances with a high global warming potential from cooling and freezing, BAT is to use refrigerants without ozone depletion potential and with a low global warming potential.

Description: Suitable refrigerants include for example water, carbon dioxide, propane and

ammonia.

Currently, NRW isn't reviewing your refrigerant use against BAT, this is something that will take place in the future, once the UK Slaughterhouse BAT is established.
