4. Details of our assessment

This CAR form is being sent to Johnsons Laundry Ltd following a pollution incident on the 24/05/25 when effluent was reportedly discharging from a manhole to nearby land and the watercourse.

Video evidence from the reporter shows soapy water discharging from the manhole. Since the incident NRW has been in contact with Johnsons laundry and the issue has been

resolved and is being monitored on a weekly basis. Stones and pebbles were identified to be the issue that resulted in the blockage.

Previously we issued a CARS form with a warning on 04/01/24 for a similar incident. We asked back then "How will you maintain this in the future to prevent any similar incidents occurring again" We would like to emphasize this point again. Why are stones and pebbles in the pipework? What action will be taken to prevent a reoccurrence of this incident? Does high tide and storm events impact the discharge and can this be predicted in the future to prevent and future incidents?

The CAR form is being scored as a permit breach CCS3 as the discharge was somewhere other than the permitted discharge point SH 44330 36850. Due to previous investment undertaken by Johnsons Laundry to resolve this matter we are issuing advice and guidance on this occasion. If future incidents occur enforcement action will be considered to ensure compliance with permit.
