**4. Details of our assessment**

In relation to Natural Resources Wales (NRW) incident investigation WIRS **2502616**, NRW identified that emissions to air took place from a fire which happened on Thursday the 13<sup>th</sup> of March 2025.

(W3B) Emissions of substances not controlled by emission limits and permit condition 3.1.1- There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3.

This was a small accidental fire and was contained on site, Gofer Bulking station followed their FPMP guidance correctly which prevented the fire from becoming established due to their swift response.

As a result, this is non-compliant under the condition 3.1.1 and NRW have issued a Compliance Classification Score (CCS) 4, A non-compliance which has no potential environmental effect.

**ACTION**

The site will need to ensure that they separate the waste receive correctly to avoid flammable waste such as batteries to come into contact with any sparks or being crushed by heavy machinery.
