Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Sampling shortfall: 1 result for BOD, Ammonia and Total Suspended Solids missing for the

calendar year.

The Permit variation effective 11/10/2024 requires monitoring at the reduced frequency for Tier 3 (no requirement to monitor at normal frequency for 12 months as there was no tightening of limits or new limits added to permit).

Sampling shortfall not reported on the ASR.

The non-compliance's listed above were identified during our annual 2024 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/24 as these non-compliance's relate to annual 2024 data, however for clarity I carried out the compliance assessment on 09/05/25.
