4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of annual returns and monitoring data (2024) that was received by Natural Resources Wales (NRW) on 30/01/25. This was received within the timescales specified by the permit.

Emissions to air

Annual air emissions monitoring was completed by an independent, third-party MCERTS accredited test house on the permitted emission points and recorded the following results:

B6: Lead- 0.42kg/yr vs permitted Emission Limit Value (ELV) of 4kg/yr

Particulates- 15.30 kg/yr vs permitted ELV of 22kg/yr.

B7: Lead- 0.056mg/m³ vs permitted ELV of 0.2mg/m³

Particulates- 1.8mg/m³ vs permitted ELV of 2mg/m³.

B24: Lead - 0.30kg/yr vs permitted ELV of 1.3kg/yr.

Particulates- 1.30kg/yr vs permitted ELV of 3.3kg/yr.

All results were therefore compliant with the permit.

Emissions to Sewer

Emissions to sample point S1 were sampled on 12/03/24 and 13/08/24 and recorded the following results:

12/03/24

Lead - 0.0639 mg/l vs permitted ELV of 0.5mg/l.

Zinc- 0.0369mg/l vs permitted ELV of 2mg/l.

13/08/24

Lead- 0.0517 mg/l vs permitted ELV of 0.5mg/l.

Zinc- 0.0121 mg/l vs permitted ELV of 2mg/l.

All results were therefore compliant with the permit.

Annual waste disposal and recovery

With reference to form W1, total waste produced at the site was lower in 2024 (250 tonnes) compared with 2023 (327 tonnes).

Annual water use

With reference to form WU1, total water use at the site was lower in 2024 (3756m3) compared to 2023 (6235m3).

Annual energy use

With reference to form E1, total energy use at the site was lower in 2024 (5,688,351KWh) compared to 2023 (6,484,757 KWh).
